

#### The Schedule (Sports Medicine Centre)

1) Name and address of the Client Singapore Masters Track & Field Association, 37 Kovan Road #17-47, Singapore 545018 (the *Address*)

### 2) Duration

It is from 1 April 2019 to 31 March 2020 with an option to extend for one year at new terms and fees to be agreed by both parties.

#### 3) Terms of the Agreement

Alexandra Health Pte Ltd is the legal entity that manages Khoo Teck Puat Hospital. Khoo Teck Puat Hospital (KTPH) will provide the contract services.

This contract can be varied by either party giving 30 days' notice or terminated by either party giving 3 months' notice.

### 4) Description of services

KTPH Sports Medicine Centre will provide care to the members and staff of Singapore Masters Track & Field Association (SMTFA) for outpatient treatment. Other services which can be arranged upon request include sports pre-participation medical screening, musculoskeletal screening, field medical coverage, sports medicine and sports science seminars, taping workshops and etc.

A medical appointment for sports medicine services can be made within 24 to 48 hours and a physiotherapy appointment within 72 hours of scheduling for an appointment.

### 5) Fees

- 5.1 The rates will apply for the treatment of sports-related issues only and must be prescribed by our doctors at KTPH Sports Medicine Centre (SMC).
- 5.2 These rates do not apply for the treatment of other medical conditions and will not apply if the members or staff is seen by other specialists in other clinics within KTPH.
- 5.3 The eligible members and staff may call our Customer Contact Centre at Tel: 6602 3333 or email <a href="mailto:KTPH.Appt@ktph.com.sg">KTPH.Appt@ktph.com.sg</a> to arrange for an appointment. Please identify as "Singapore Masters Track & Field Association". On the day of the appointment, the members or staff should bring along their NRIC and SMTFA referral letter to KTPH for registration.
- 5.4 Members and staff of SMTFA are to self-pay for all the services on the day of appointment.

#### 5.5 Rates

#### 1. Sports Medicine Consultations and Clinic Procedures

- a. \$80.00 for new and follow-up sports medicine consultation (Maximum of 2 visits)
  - Based on each individual referral
  - Subsequent visits will be based on prevailing private rates according to the doctor's rank
- b. Corporate rates for clinic procedures (Appendix 1)

## 2. Radiology and Advanced Imaging Investigations

- a. Prevailing rates for common radiology services
- b. Prevailing rates for common advanced imaging investigations

#### 3. Blood and Urine Investigations

### 5. Common Physiotherapy Services in Sports Medicine Centre

- a. First Visit at \$140.00 and Repeat Visit at \$125.00 per visit
  - No limit on modalities per visit
  - Physiotherapy visits do not include: i) KT2000 and ii) Biodex Assessment
- b. Rate for Group Class (See Appendix 3)

#### 6. Sports Medicine On-site Consultation Service

- a. We will provide on-site consultation service and will charge a minimum of 2 hours per session, which includes transportation time.
- b. If SMTFA intends to cancel a consult session, notification to KPTH Sports Medicine Centre at least one (1) week in advance is necessary. If at least one (1) week notice not provided, KTPH will still continue with the service and charge as session rate as detailed in the table below.
